



OVERVIEW


The De-Registration process allows Clubs, Associations and Member Federations to de-register a participant.

Clubs or Participants can request a de-registration and will only be completed once approved.








HOW TO FIND DE-REGISTRATION REQUESTS

STEPS

- 1. Select the Registration tab
- 2. Select De-reg request from the side menu to view the status of all de-registration requests within your organization.


This screen will allow you to filter by date, status or search the request by FFA Number




Status Descriptions:

- Approval Required De-registration commenced by either Club or Participant AND it's awaiting Participant or Club acceptance (e.g. if a Club actions the De-reg it will be in the Approval Required status until the Participant accepts it)
- Approved De-Registration fully approved
- Declined De-Registration declined by Second Level (Association or Federation)
- Second Level Approval Required Awaiting Second Level approval by (Association or Federation)
